

Fosterline Wales Factsheet Transferring fostering agency

Introduction

Sometimes, foster carers want to change their agency, for a variety of reasons. Foster carers have the right to free movement between fostering agencies. However, foster carers can only be registered with one agency at a time. If a foster carer is fostering a child or young person, that child or young person's needs must be paramount in any decisions and in the plans for transferring to another agency.

Although people often talk about transferring agency, in reality it involves applying to a new agency and resigning from the current agency. Wales does not currently have an agreed transfer protocol. Transfer protocols guide the way in which fostering services should manage the movement of foster carers between fostering services, although many agencies choose to use <a href="https://doi.org/10.1001/jhttps://doi.org/1

Reasons for transferring

There are many reasons why a foster carer might which to change to another fostering agency:

- lack of children placed with you
- poor matching in previous placements
- · improving the support to the fostered children or yourself
- availability of training and career development
- moving home and wanting to foster for a local agency
- disagreement with your current fostering agency
- terms and conditions

No agency should approach you to ask you to move to them, neither should an agency pressure you to transfer. An independent agency should not try to 'poach' you from the local authority or even vice versa. The local authority who placed a child or young person with you should not pressure you to transfer to them as a condition of a child or young person remaining with you.

The transfer process

If you want to change your agency, you will need to apply to a new agency and once approved, you will need to resign from your current agency, giving your current agency 28 days' notice on or before the date of your approval with your new agency. The regulations around approval and resignation apply when you transfer agency, not just your initial approval and when you stop being registered as a foster carer.

You can approach a new agency without telling your current agency. However, you need to tell your current agency before you formally apply to a new agency. If you have a child in placement, you also need to tell the local authority that placed the child with you, of your application to a new agency

The agency you apply to will ask your current agency for a reference and will usually request a copy of your assessment paperwork. The assessment paperwork belongs to your current agency, and they are not obliged to pass it on. They are, however, obliged to provide a reference.

The reference should include the following information about the fostering household:

- length of registration
- current approval category (if any) and date this was agreed
- significant variations in approval in the last five years
- age, sex and length of stay of all foster children during the last five years
- extent to which the foster carers were able to achieve placement objectives
- strengths and skills of the foster carers
- recent training courses attended by the foster carer/s and skills gained postapproval
- date and outcome of any investigation of allegations or concerns
- details of any current allegations or concerns
- a copy of your last annual review report

The agency to which you apply will need to carry out a full assessment. If your current agency has provided your assessment paperwork, there will be some information that does not need collecting again. Your training record belongs to you, even if held by your current fostering agency, so you can request it and use it as evidence of prior training.

Once the new agency has indicated they will be recommending to approve, you should write a letter of resignation to your current agency. This takes effect 28 days later. If you currently have a placement, it is essential the two agencies coordinate timings, so you are deregistered by your current agency on the same day as you are approved by your new agency.

The entire process typically takes three to four months but can take longer.

Transferring while a child or young person is in placement

It is possible to transfer agencies while a child or young person is in placement. The child or young person's interests must come first in any decision about whether they stay with you, by moving to the new agency, or move to another placement.

You must give written notice to your current agency that you plan to move to another agency. If you are not fostering for the local authority that placed the child with you, then you must also notify that local authority. The local authority will notify the child's Independent Reviewing Officer who will convene a review meeting of the placing authority, the current agency, the agency you are applying to and yourself.

The final decision about whether or not the child or young person remains with you is made by the local authority who placed them with you.

The Fostering Network protocol lays out the arrangements between agencies when a child or young person remains with you. If your agencies have not agreed to operate under the protocol, you may still want to check the protocol to see what kind of good practice arrangements need to be made.

When something goes wrong

Transferring is not always smooth. The agency to which you apply may postpone the presentation of your assessment to their panel, or recommend not to approve you. Your current agency may not make the transfer easy for you. The Independent Review of Determinations (Adoption and Fostering) (Wales) Regulations 2010 explains your rights to challenge to the Independent Review Mechanism (IRM) a decision not to approve you. If you wish to make a complaint against your current agency, you can use the Social Services 'official complaints' procedure (if a local authority) or the agency's own complaints procedure.
